- Isolate the kitten for a period not less than 14 days.
- Kitten is guaranteed to be of good health at the time of sale, and for a period of 72 hours. You must have the kitten examined by a certified veterinarian within 72 hours of the kitten delivery. *Please note* that failure to do this will render all guarantees null and void.* If the kitten is found to be ill, during that time (First 72 hours), it must be reported immediately, with written confirmation from a certified veterinarian. If the condition is treatable, Pedigree Bengals will reimburse for reasonable and customary vet medical charges. If the kitten is found to be medically deficient with an un-treatable or life-threatening condition steps will be taken to provide for the return of the kitten. Upon the return of the ill kitten a replacement kitten of equal value will be provided as the next litter permits, but not to exceed 6 months.
- Under no circumstances will this kitten be sold, lent, given, or abandoned to a shelter, pound, animal humane organization, veterinarian, researcher organization, or any similar organization or person. Should purchaser be unable to keep

kitten/cat the Seller is to be notified and at the Sellers discretion, kitten is to be returned to seller or suitable new home is to be approved by seller.

- Never have any of the kitten's paws de-clawed, it's inhumane for *many* reasons.
- Kitten will be current on vaccinations at time of pick-up. It is the Buyers responsibility to obtain proper vaccinations for the kitten on a schedule determined to be proper by a certified veterinarian.
- Kitten is to be provided with a safe and healthy environment. Kept clean, well fed with nutritious food and fresh water. Bengals are a wild breed and thrive on meat for example, cooked chicken for deboned fish.
- This kitten is Not allowed to be bred and will require spay/neuter within 6 months of time of sale. Proof must be provided in written form from certified vet to receive TICA certified papers.
